

**Highlands Ranch Law Enforcement Training Facility &
CODE303 Douglas County Emergency Vehicle Driver Training Center
2020
Fee Schedule**

The Board of Directors of the Highlands Ranch Law Enforcement Training Foundation Inc. sets all fees and determines what organizations will be allowed access to, and use of, the facility.

Range & Classroom Fee Assessments:

Full-time Use Agency: Agencies and organizations that are approved by the Board and receive unlimited use (based on scheduling availability) of the entire facility (ranges, classrooms, firearms simulators, shoot house, SIMTEK Simunitions house, PT field) and pay an annual fee each calendar year. Fees are assessed at a rate per calendar year as set by the Board. For 2020, Full-time Use Agencies pay a flat fee of \$285 per individual armed/commissioned person, per calendar year. *

Formula: number of commissioned persons in the agency X \$285 = annual fee for that agency

**An exception to the above formula applies, beginning in 2018, for Full-time Use Agencies that have 10 armed/commissioned persons or less; those agencies pay an annual flat fee of \$2500 per calendar year.*

**Other personnel which are obligated to train on a less frequent basis and use firearms under the authority and direction of any Full-time Use Agency will be assessed a separate fee as determined by staff. This would include Reserves, Posse, Special Officers and Code Enforcement appointments or invitees from other agencies who are not Full-time Use Agencies.*

Occasional Use Agencies: Agencies or organizations that are approved by the Board and receive use (based on scheduling availability) of the entire facility (ranges, classrooms, firearms simulators, shoot house, Sims house, PT field), and pay fees on a pay-per-each-use basis, up to four (4) times per calendar year. Any private training company or organization which provides any training session or competition and charges a fee for that service is assessed fees as an Occasional Use Agency. Pay-per-each-use fees are noted below.

Note – Scheduling multiple areas within same period could result in some reduced pricing.

* A \$10 one-time fee per person, per each scheduled range event and scheduled range area (for cleanup, use of target stands, and lead mitigation). Weekly rates for ranges will be assessed a one-time \$10 per shooter clean up lead mitigation fee.

Lessee User: These are agencies or organizations approved by the Board, who lease space, or are based at, the HRLETF in a defined area for a prescribed period of time (example: County Sheriffs of Colorado Inc., DCSAR and NecroSearch International Inc.) Fees will be assessed as stated above for Occasional Use Agencies, except that a classroom will be free for any single day use unless there is a conflict with a Full-time User Agency or scheduled Occasional Use Agency. Any classroom scheduled for two or more days will be assessed \$75 per day including first day.

Users Who Charge Fees for Training at the Facility: If any User hosts a training or seminar and charges the attendees fees that are payable to the User, then the above Occasional User Agency fees apply. Agency must submit a request and the training curriculum to the Board when submitting your range request or at least three months prior to the training. If you fail to submit the requested material your membership could be forfeited. The rate is for a full day, there is no pro-ration.

Driver Training Center Fee Assessments:

The CODE303 Douglas County Emergency Vehicle Operation Center (EVOC), at 8500 N. Moore Rd, is owned by Douglas County and managed by the Highlands Ranch Law Enforcement Training Foundation. It is a public-safety driver training facility—it is not designed or intended for extreme driving or racing. It offers a great place to teach advanced decision making; safe pursuit driving and pursuit termination; communication while driving; low speed technical driving skills; day and night driving; inclement weather skills; vehicle dynamics and limitations; law enforcement motorcycle certifications; crash investigation training; the most recent approaches to traffic incident management (TIMS); and local teen and senior driver safety program(s). Hours of Operation:

Monday through Friday – Opens at 08:00 hours; Closes at 21:00 hours

Scheduling periods in 6 hour increments:

1. 08:00 hours till 14:00 hours
2. 14:30 hours till 20:30 hours

Saturday and Sunday – Opens at 08:00 hours; closes at 18:00 hours

Scheduling periods in 5 hour increments:

1. 08:00 hours- 13:00 hours
2. 13:00 hours- 18:00 hours

Vehicle Use Legend:

1. **Vehicle (V)** - not to exceed 8000 GVRW. To include average PU trucks, ATV, bicycles and Motorcycles.
2. **Large Vehicles (LV)** – not to exceed 35,000 GVRW. To include school buses- some fire trucks- MCP- 4x4 special use vehicles- Public Works equipment.
